1. INTRODUCTION

- 1.1. Mento Markets Ltd. is running refer a friend scheme (the "Referral Program") and is available to new and existing Clients of Mento Markets to participate. By participating in this program, you agree to be bound by these Terms and Conditions herein (hereinafter the "Terms") as these are set out below.

2. INTERPRETATION OF TERMS

- 2.1. In these Terms, the following words shall have the following meaning:

Account:

Shall mean a personalized trading account that the Client holds with Mento Markets, designated with a unique account number, and used for the purposes of trading through Mento Markets

Referrer:

Shall mean the Mento Markets client who refers a friend via a generated referral link.

Referee:

Shall mean the new Client of Mento Markets who registers through the "referrers" generated referral link.

Client Agreement:

shall mean the agreement entered between a Client and Mento Markets, including these Terms, and any other policy posted on the Website, as may be amended by Mento Markets from time to time, and the last version shall be available by accessing the Website.

Mento Markets

Shall refer to Mento Markets Markets Direct Castries, Saint Lucia operating and trading under Mento Markets brand, Mento Markets, Mento Markets at www.mentomarkets.com.

Website

Shall mean www.mentomarkets.com as applicable.

Referral Program Duration

The Referral Program has been instituted for an indefinite period. Mento Markets retains the right to unilaterally terminate this Referral Program at any time, without prior notice.

- 2.2.** Any words whose meaning is not defined herein shall have the meaning provided in the Client Agreements.

3. REFERRER ELIGIBILITY CRITERIA

- 3.1.** To participate in the Refer a friend scheme, you must meet the following requirements as a ("Referrer"):

- A. be a verified client;
- B. have funded the account with a sum of at least \$100;
- C. have opened and closed at least 3 lots in Forex or Metals (excl. GOLDoz and GOLDgr) within the last 60 days;
- D. minimum trade duration: orders with a duration of less than 5 minutes will not be considered;
- E. your account is registered under Mento Markets Markets Direct Castries, Saint Lucia, Mento Markets.

4. REFEREE ELIGIBILITY CRITERIA

- 4.1.** To participate in refer a friend scheme, you must meet the following requirements as a ("Referee"):

- A. is a new client of Mento Markets (Mento Markets Markets Direct Castries, Saint Lucia, Mento Markets Limited), and does not already hold any active/inactive accounts with Mento Markets;
- B. is successfully verified;
- C. have funded the account with a sum of at least \$100;
- D. have opened and closed at least 3 lots in Forex or Metals (excl. GOLD oz. and GOLD gr) within the last 30 days;
- E. minimum trade duration: orders with a duration of less than 5 minutes will not be considered;
- F. all the above actions should be made within 30 calendar days of successfully completing the first step of registration.

5. REWARD TERMS

- 5.1.** In order to receive the reward, both the 'Referrer' and 'Referee' must first meet the conditions listed above.
- 5.2.** Referee will receive a withdrawable one-off cash bonus of \$50.
- 5.3.** Referrer will receive a withdrawable cash bonus of \$50 for each client referred.
- 5.4.** This bonus will be transferred directly to the Client's trading account and is applicable to be withdrawn, and available for trading purposes.
- 5.5.** Any profits made by clients through trading with the 'bonus' are available for withdrawal.
- 5.6.** There are no limitations to the number of referrals each Client can make.

6. MISCELLANEOUS

- 6.1** In the event of any dispute or misinterpretation of the above applicable Terms, such dispute or misinterpretation shall be resolved by Mento Markets, acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. Mento Markets decision shall be final and binding.
- 6.2** Under no circumstances will Mento Markets be liable for any losses that Client may incur as a result of trading activity in the Account. This Referral Program is not intended to change any client's risk preferences or investment strategies and Mento Markets accepts no responsibility for the same.
- 6.3** Notwithstanding any other provision of these Terms, Mento Markets shall have the sole discretion to determine Client's eligibility under these Terms.
- 6.4** Mento Markets has the right at any time and its absolute discretion to disqualify any Client who has accepted the current Terms and/or withdraws any profit gained if:
 - A breach of these Terms and/or of any term of the Client Agreements occurs;
 - Mento Markets has reasonable grounds to believe misuse of the current Terms;
 - The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in the spirit of the current Terms.
- 6.5** Any indication or suspicion of fraud, manipulation, cash-back or credit or swap arbitrage, or other forms of deceitful or fraudulent activity in a Client's Account or multiple Accounts with Mento Markets or otherwise

- 6.6** By accepting the current Terms, the Client acknowledges that it has read and agreed to be bound by these Terms together with the Client Agreement as well as to all other business terms and conditions as these may be applicable and/or amended from time to time.

In the event of any discrepancies between these Terms and the Client Agreement, these Terms will prevail but only in relation to the eligible Accounts.
