1. INTRODUCTION

1.1. Mento Markets is running a refer a friend scheme (the "Referral Program") and is available to new and existing Clients of Mento Markets to participate. By participating in this program, you acknowledge and agree to be bound by these Terms and Conditions herein (hereinafter the "Terms") as these are set out below.

2. INTERPRETATION OF TERMS

2.1. In these Terms, the following words shall have the following meaning:

Account

Shall mean a personalized trading account that the Client holds with Mento Markets, designated with a unique account number, and used for the purposes of trading through Mento Markets.

Referrer

Shall mean the Mento Markets client who refers a friend via a generated referral link. Referee shall mean the new Client of Mento Markets who registers through the referrer's generated referral link.

Client Agreement

Shall mean the agreement entered between a Client and Mento Markets, including these Terms, and any other policy posted on the Website, as may be amended by Mento Markets from time to time, and the last version shall be available by accessing the Website.

Mento Markets

Shall refer to any affiliated entity of Mento Markets, operating and trading under the Mento Markets brand, which is specifically designated as participating in this Promotion and available at www.mentomarkets.com.

Website

Shall mean www.mentomarkets.com as applicable.

The Referral Program has been instituted for an indefinite period. Mento Markets reserves the right to unilaterally modify, suspend, or terminate this Referral Program at any time, without prior notice.

2.2. Any words whose meaning is not defined herein shall have the meaning provided in the Client Agreements.

3. REFERRER ELIGIBILITY CRITERIA

3.1. To participate in the Referral Program as a Referrer, you must meet the following requirements:

- a. Be a verified Client of Mento Markets (as defined herein);
- b. Have funded the Account with a sum of at least \$100;
- c. Have opened and closed at least 3 lots in Forex or Metals (excluding goldoz and goldgr) within the last 60 days;
- d. Minimum trade duration: orders with a duration of less than 5 minutes will not be considered;

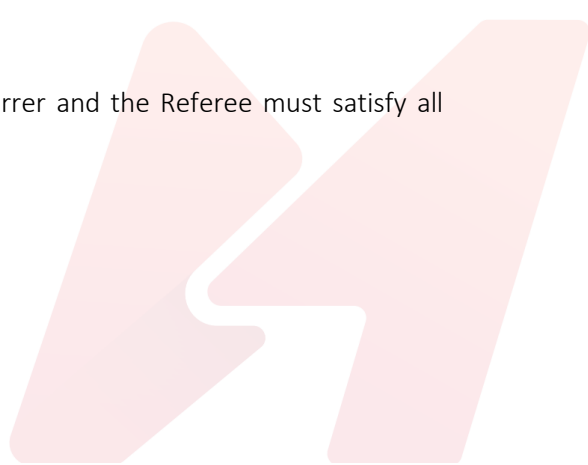
4. REFEREE ELIGIBILITY CRITERIA

4.1. To participate in the Referral Program as a Referee, you must meet the following requirements:

- a. Be a new Client of Mento Markets (as defined herein) and not already hold any active or inactive Account with Mento Markets;
- b. Be successfully verified;
- c. Have funded the Account with a sum of at least \$100;
- d. Have opened and closed at least 3 lots in Forex or Metals (excluding goldoz and goldgr) within the last 30 days;
- e. Minimum trade duration: orders with a duration of less than 5 minutes will not be considered;
- f. All the above actions should be made within 30 calendar days of successfully completing the first step of registration.

5. REWARD TERMS

5.1. To qualify for any reward under the Referral Program, both the Referrer and the Referee must satisfy all





applicable eligibility requirements set out in these Terms.

5.2. An eligible Referee shall receive a withdrawable one-off cash reward of \$50.

5.3. An eligible Referrer shall receive a withdrawable cash reward of \$50 for each Client referred.

5.4. Cash reward shall be credited directly to the eligible Client's Account and may be used for trading purposes or withdrawn, subject to these Terms and the applicable Client Agreement.

5.5. Any profits generated from trading activities conducted using the credited reward funds shall remain the property of the Client and may be withdrawn in accordance with the applicable Client Agreement and account terms.

5.6. There is no limit to the number of eligible referrals a Referrer may make under the Referral Program.

6. MISCELLANEOUS

6.1. Mento Markets reserves the right, at any time and at its sole discretion, to modify, suspend, restrict, withdraw, or terminate the Referral Program, in whole or in part, with or without prior notice.

6.2. In the event of any dispute or misinterpretation of the above applicable Terms, such dispute or misinterpretation shall be resolved by Mento Markets, acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. Mento Markets decision shall be final and binding.

6.3. Under no circumstances shall Mento Markets be liable for any losses that Client may incur as a result of trading activity in the Account. This Referral Program is not intended to change any client's risk preferences or investment strategies and Mento Markets accepts no responsibility for the same.

6.4. Notwithstanding any other provision of these Terms, Mento Markets shall have the sole discretion to determine Client's eligibility under these Terms.

6.5. Mento Markets has the right at any time and its absolute discretion to disqualify any Client who has accepted the current Terms and/or withdraws any profit gained if:

- A breach of these Terms and/or of any term of the Client Agreements occurs;
- Mento Markets has reasonable grounds to suspect misuse, abuse, or manipulation of the Referral Program;
- The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in the spirit or intended purpose of the Referral Program.



6.6. Any indication or suspicion of fraud, manipulation, cash-back or credit or swap arbitrage, or other forms of deceitful or fraudulent activity in a Client's Account or multiple Accounts with Mento Markets or otherwise related or connected to the Referral Program may result in the cancellation of all related transactions and the forfeiture of any profits, bonuses, or benefits derived therefrom.

6.7. By participating in the Referral Program, the Client acknowledges that it has read and agreed to be bound by these Terms together with the Client Agreement as well as to all other business terms and conditions as these may be applicable and/or amended from time to time.

In the event of any discrepancies between these Terms and the Client Agreement, these Terms will prevail but only in relation to the eligible Accounts participating therein.
